MINUTES OF THE MEETING OF THE RESOURCE MANAGEMENT COMMITTEE HELD ON 8 DECEMBER 2009 AT THE OFFICES OF THE WEST COAST REGIONAL COUNCIL, 388 MAIN SOUTH ROAD, GREYMOUTH, COMMENCING AT 10.32 A.M.

1. APOLOGIES

There were no apologies.

2. MINUTES

Moved (Scarlett / Robb) that the minutes of the previous Resource Management Committee meeting dated 9 November 2009, be confirmed as correct.

Matters Arising

There were no matters arising.

3. PRESENTAION

The Chairman welcomed Mr Stephen Keenan and Mr Graham Monk to the meeting. Mr Keenan is a Deer Farmer from Kowhitirangi and Mr Monk is a Dairy Farmer from the Kokatahi Kowhitirangi Valley. They wish to discuss water quality and farm effluent problems. Mr Keenan stated that the catalyst for their visit today is the \$50,000 fine imposed on Mr Keenan's neighbour, Mr Tom Taft, by the Environment Court for the discharge of untreated dairy effluent. Mr Keenan stated that the local community feel that Mr Taft's fine was bordering on the extreme. Mr Keenan gave a detailed description of Mr Taft's effluent system and spoke of the amount of rainfall the Kowhitirangi area receives annually. Mr Keenan stated that the heavy rainfall helps to mitigate the problem with effluent in the waterways. Mr Keenan spoke of the problems encountered with Canadian Geese and the pollution he feels they cause to the waterways. Mr Keenan stated that Didymo is now having a big environmental impact on waterways and he feels it is likely that it was introduced by the fishing Mr Keenan stated the gorse covered river islands leach Nitrogen into waterways and may be more problematic than intensive dairy farms. Mr Keenan spoke of the problems tourists are causing by travelling in un-serviced vans. He stated that highway laybys are now resembling outside toilets, he feels this could be linked to the spread of E Coli and Giardia. of the fines imposed on OceanaGold and Pike River Coal Ltd he feels that they should have been proportioned on the same ratio as Mr Taft's fine. Mr Keenan spoke of other environmental concerns such as leaching of toxic sludge at Ruatapu and the Westland District Council Dumpsite. Mr Keenan stated that farm effluent is grass that has gone through the stomach of a cow and stated that it is organic. Mr Keenan stated that people come from all over the world to fish the creeks in his area. He spoke of the improvements made to the dairy industry with the fencing of riparian strips and the bridges for stock to cross. He stated that effluent systems have been greatly improved over the vears. Mr Keenan requested that dairying be treated the same as every other industry or organisation. Mr Keenan is not happy about farmers being sent to the Environment Court in the first instance. He would like everyone to be treated evenly.

Mr Monk addressed the meeting and stated that he supports Mr Keenan. He thanked Council for hearing him. Mr Monk stated that if there is a problem with the way a farmer is operating then he

would like Council staff to meet with the farm owner on the spot and not talk to workers. Mr Monk stated that his run off receives 200 inches of rain a year and this is very hard to manage. He remains concerned with the fact that the Environment Court imposed such a large fine on Mr Taft. He drew attention to farm workers in South Westland who were given community service for their offences because they have no money to pay a fine.

Cr Ewen thanked Mr Keenan and Mr Monk for their presentation and stated that this Council does take an evenhanded approach to these matters. Cr Ewen reminded the meeting that the RMA is about affects and whether they are positive or adverse this Council has to address them. Cr Ewen stated if Council defaulted on its role then Council's function could be passed onto an Environmental Agency and if this were to happen, one chance would be given and that would be it. Cr Ewen reminded everyone present that the RMA has been in place for 20 years and the parties who have the privilege of utilising land, and have consents to do so, have an obligation to abide by those consents. Cr Ewen stated that once a case goes to Court then it is out of Council's hands.

Cr Birchfield stated that he does not like the way Council is going with prosecutions, he feels farmers are not being given a fair go, but he is in the minority and he agrees with Mr Keenan and Mr Monk. C. Ingle reminded Councillors that during a presentation standing orders do not allow Councillors to express their opinions, just to ask a question of clarification. Cr Archer thanked Mr Keenan and Mr Monk for their presentations and stated that he takes on board their comments about fairness. Cr Archer asked Mr Keenan and Mr Monk if the performance objectives in the regional plans are unrealistic or should be changed as these are what are currently used as benchmarks. Mr Keenan responded that he has not had the chance to study these but he feels that some dairy farmers would have better effluent systems in place than a lot of residential townships in New Zealand. Mr Keenan stated that due to the high rainfall there is no way of avoiding some effluent entering water. Mr Keenan wants the same latitude afforded to farmers that is afforded to other industries. He would like the Environment Court to be the last call on the map and not the first cab off the rank when is comes to solving these problems, he would like the Council to solve these problems first up and as the last resort, go to the Environment Court. Cr Scarlett stated that the Councils position is firstly, lets get it right, secondly a fine is imposed, thirdly an abatement notice is issued, fourthly it is prosecution and this is the situation in this Council. Cr Scarlett stated that we try to be conciliatory and try to get things right but Council has a statutory obligation to take things further if it isn't put right.

4. CHAIRMAN'S REPORT

Cr Ewen reported that he and Cr Scarlett attended the Regional Land Transport Committee meeting earlier this month. Cr Ewen reported that three tenders were let during the month for minor work and reinstatement work. The evaluation process for the tenders for Greymouth Floodwall Upgrade was completed earlier this month. Cr Ewen advised that five tenders were shortlisted and the successful tender will be announced next Tuesday. Cr Ewen reported that he dealt with inquiries regarding gravel extraction at Blaketown and the Cobden floodwall and the Cobden outlet.

Moved (Ewen / Davidson) that the Council receive this report.

5. REPORTS

5.1 PLANNING AND ENVIRONMENTAL GROUP

5.1.1 PLANNING AND ENVIRONMENTAL MANAGER'S MONTHLY REPORT

- S. Moran spoke to his report advising that he has been busy working on his evidence for Wetlands Variation 1. Evidence in chief has been exchanged and he is currently working on rebuttal evidence. The hearing is due to start next Monday.
- S. Moran provided an update on the Plan Merge, he advised a decision on the notification will be brought to the February Council meeting.
- S. Moran reported that the weather radar remains on track.
- S. Moran advised that transport matters were discussed at the recent Regional Land Transport Committee meeting. He offered to email information and maps to Councillors relating to the West Coast State Highway Route Security Studies Updates and the West Coast Passing Opportunities Study Update.

S. Moran reported that contact recreation monitoring programme has been reviewed against the Ministry for the Environment guidelines and as a result some of the sites that have been continually clean now do not need to be monitored anymore. He advised that some new sites have been put in and re-sampling of the good sites will be done again in a few years time. S. Moran offered to answer questions from Council.

Cr Archer asked if there has been any response to the letters that were sent out to the Ministers and DoC regarding the Wetlands hearing and the likely legal costs that might be incurred. Cr Scarlett stated that he has had a letter back from the Associate Minister, Kate Wilkinson, who said that she supports what DoC is doing and that it is their duty to be challenging it. Cr Scarlett stated he received a letter from the Director General of DoC, Mr Al Morrison. Cr Scarlett reported that Mr Morrison gets several things wrong, he thinks the Council is taking DoC to court, he believes that the answer to resolving the issue outside of the court hearing is to get back to the table and reignite the constructive decisions that (allegedly) Council unilaterally withdrew. Cr Scarlett stated that this was a most unsatisfactory letter. Cr Scarlett has been in contact with Hon Chris Auchinvole who is going to see both the Minister and Mr Morrison but the Minister is currently involved with the Copenhagen summit on climate change. Cr Scarlett stated that with the feedback to date it looks as though we are going to court. Cr Scarlett advised that if Council were to be successful in the court hearing then the Conservation Act could change. This would be because DoC have not considered the wellbeing of communities and have looked at it from a very narrow perspective and are saying that it is purely an ecology issue. Cr Scarlett stated the RMA requires us to take into consideration communities and economic considerations as well. He feels DoC is looking at this issue from a very lopsided point of view and Mr Morrison is completely bereft of the facts. Cr Scarlett is very surprised that the Director General could get this so wrong. C. Ingle explained the process from the start and where we are at now, he advised that DoC is acting under their own conservation legislation which says they shall be advocates for conservation. C. Ingle stated that the question is, is being an advocate for conservation going as far as taking someone to court or is being an advocate for conservation just being helpful and providing information and making submissions but not going as far as the Environment Court. C. Ingle suggests this may become a reason for the Government to consider making changes to the Conservation Act to make it clear that their advocacy role does not include taking councils to the Environment Court. C. Ingle stated that he believed that elected Councillors have a mandate to make decisions on behalf of the community and can't see why DoC has the right to overrule this. Cr Ewen clarified that DoC are taking the West Coast Regional Council to court and not the other way around. Cr Scarlett advised that unless DoC gets instruction from the Minister or the Conservator they are not going to withdraw. Cr Ewen stated that Council's decision was based on the fact that wetlands on private property were to be included and Council wishes to protect the rights of private property owners.

Cr Chinn is concerned that when the person at the top of DoC gets is so wrong we need to put him right. Cr Ewen asked that a very concise note be sent to Mr Morrison.

Cr Ewen asked S. Moran if the extra work being undertaken at Lake Brunner is being done out of the existing budget. S. Moran confirmed that it is.

5.1.2 BIOSECURITY ACT REVIEW

C. Ingle spoke to this report. He advised that this is really a pre-warning that changes are to Biosecurity Act are being considered. C. Ingle advised that the Act has been in place since 1993 and there has been very little change to it during this time. The Minister has advised that there are improvements that need to be done to bring it up to the demands that are impacting on it today. C. Ingle advised that the Biosecurity Act is perhaps our most important piece of legislation second to the RMA. He stated the most relevant part of the Act to this council is the pest management area where we have a Regional Pest Plant Strategy in place. C. Ingle advised that the discussion document states that the Act has a lack of obligation on any particular agency to undertake activities in pest management thus allowing for a situation where no one takes the lead and no decision is made. C. Ingle stated it is possible that government is saying that because we don't have an animal pest management strategy in place for the West Coast nobody is taking the lead on this on the West Coast. He suggests that clarification is sought regarding this issue so that we can asssess the impact it could have on this Council. Cr Ewen stated that the varroa outbreak is an example of a poor response and the lack of a good strategy in place to deal with such an outbreak. Cr Ewen would like to see this tightened up to avoid a repeat of this scenario to ensure that the crown takes responsibility where necessary. Cr Archer asked if C. Ingle has an indication of the costs involved to

participate in the review. C. Ingle responded that he has not had time to do a detailed assessment of the review but he feels the costs will not be significant.

- 1. That Council receive this report.
- 2. That Council agree to write a short submission to MAF Biosecurity by 23 December 2009, expressing:
 - a. Support for the changes to bind the crown as a land owner;
 - b. Support the changes to broaden enforcement options; and
 - c. Request more information on the implication under bullet point 4 of pest management that pest strategies may become mandatory.

5.2 CONSENTS AND COMPLIANCE GROUP

5.2.1 CONSENTS MONTHLY REPORT

C. Dall reported that the month has gone quickly as he has been busy preparing evidence for the Wetlands hearing. C. Dall reported that one further mediation meeting is to be held before the end of the year between TrustPower and Mr Groome; this is scheduled for the 21^{st} of December. He stated should this fail to resolve the matter then it will proceed to an Environment Court hearing early next year. T. Scott asked C. Dall what is the purpose of diverting Duffers Creek. C. Dall responded that this is in relation to a gold mining operation. Cr Chinn advised that Duffers Creek is cutting in and eroding in this area. C. Dall advised that it is a small section of the creek that is being permanently diverted.

Moved (Scarlett / Birchfield) that the December 2009 report of the Consents Group be received.

5.2.2 COMPLIANCE & ENFORCEMENT MONTHLY REPORT

C. Dall reported that it is unusual the high proportion of complaints this month were found to be in breach of rules or the RMA with only 31% fully compliant. C. Dall reported that dairy sheds visits to inspect dairy effluent discharges have revealed some non-compliances and compliance staff noted that most related to poor maintenance of the effluent system. C. Dall reported that staff are having ongoing discussion with Westland District Council regarding wastewater treatment systems. C. Dall reported that IPL are continuing to pump the CCA contaminated groundwater to a sump for re-use in the timber treatment process. He advised that approximately 4,400 kgs have been retrieved to date. C. Dall advised that complaints are being received regarding the ongoing gravel extraction at Blaketown Beach. C. Dall stated that Westroads intend to move from the site by the end of this week and will relocate elsewhere until February next year. C. Dall advised that the main issue is the stockpiling of gravel on the beach. Cr Scarlett asked how far from the CMA are they? C. Dall responded that he had not measured it, but he estimated it is about 30 metres. C. Ingle advised that the reason for the 50 metres from the CMA in the Land and Riverbed Plan is to avoid people digging into the shoreline that could cause erosion of the land. A stockpile is building up the shoreline and if anything would be preventing erosion. C. Dall advised Cr Scarlett that in the Council's view the stockpiling of gravel affects are minor at worst.

- C. Dall reported that there have been ongoing complaints about water quality in the Ngakawau River. He stated this seems to be a case of where people notice the discolouration of the water, which is an aesthetic affect but the actual impact on the aquatic ecosystem is positive.
- C. Dall reported that the Strongman Mine Harrison Ridge Cutback Project has been successfully carried out with the contractor concerning having done a good job. Cr Ewen concurred that this is a big improvement and he is pleased that the moving of the ridge has been avoided.
- C. Dall reported that the seven work programmes for mining were processed within the 20 day target.

Notified Consents Updates

The Consents & Compliance Manager attended a further mediation meeting on 21 December 2009 in relation to the J Groome appeal on the resource consents granted to TrustPower Limited for its proposed Arnold Valley Hydro Power Scheme. It was agreed at the meeting that Mr Groome would not proceed with some aspects of his appeal and that caucusing would take place between Mr Groome's and TrustPower's freshwater ecological experts. Since then, caucusing between the planning experts (including the Consents & Compliance Manger) has also been agreed to, with the caucus meeting scheduled to occur in Christchurch on 3 February.

The Hearing Committee for the consent applications lodged by Hydro Development Limited (HDL) for its proposed hydropower scheme on the Stockton Plateau released its decision on consent applications on 18 January. The Committee granted HDL all the consents it sought and recommended to the Minister of Conservation that she grant the consent required for the installation of the offshore discharge outfall for the scheme. The appeal period closes 10 February.

Public Enquiries

49 written public enquiries were responded to during the reporting period. 32 (65%) were answered on the same day, 11 (22%) the following day, and the remaining 6 (12%) no more than 10 working days later.

Specific Issues

Dairy Effluent Discharges: Inspections continued throughout the Region. Council staff found some instances of non-compliance which have been dealt with in accordance with the Council's Enforcement Policy. These non-compliances mostly related to poor maintenance of the effluent system.

Council staff have continued to push the importance of storage for those farms irrigating effluent to land. This has been well received by the majority of farmers and the Council will host an effluent management field day in the Springs Junction/Maruia area in February.

Beach Gravel Extraction – Westroads: Westroads has submitted work programmes for all four of its mining licences for gravel extraction from South Beach to Blaketown.

The work programmes did not include recent beach profile information. The Council will not authorise the extraction of gravel for 2010 until the beach profile information has been submitted and that information shows gravel volumes above the 1994 levels.

Pike River Coal Mine – Pike River Coal: The Company is still testing the mine's coal processing plant to ascertain whether an additional thickener will be required to ensure compliance with the consent limits for the process water discharge to Big River.

Subsidence monitoring is due to begin in-line with the start of the hydro-mining. The Company is installing field equipment for terrestrial surveying and photographing the steep slopes/outcrops. The mine site has also been flown for LiDAR as a baseline study.

Oceana Gold Globe – Progress: The "Year 6 Annual Work Plan" for the mine was submitted and accepted during the last reporting period. Council staff undertook a site visit as part of this process.

It was noted that the Company had improved some aspects of the mine's water management systems, especially at Devils Creek with the installation of a clean water by-pass pipeline. This increases the effectiveness of the Devils Creek sediment dam by allowing sediment-laden mine water to be retained longer, thus providing improved settling/treatment.

The Council received the 2009 "Bond Review and Risk Assessment Report" for the mine, which was prepared by Golder Associates. This report recommended that the bond for the mine be increased for the coming year for the following reasons:

- Increased disturbance area
- Increased backfill volumes for the General Gordon Pits
- A marked increase in estimated costs for walkway re-establishment
- A marked increase in costs in operating the water treatment plant at closure
- A increase in the estimated cost of the Saddle Dam spillway construction
- Increases in closure monitoring costs and the cost of dam safety inspections

Stockton Opencast Mine

The Annual Work Programme for the mine was approved by the Council during the last reporting period after a detailed examination of the programme and a visit to the mine to view areas of interest.

A number of interesting sediment control initiatives are currently being tested by SENZ, including the pumping of sediment (sludge) from settling ponds to geo-textile bags in order to de-sludge difficult to reach areas of settling ponds. The sludge is mixed with flocculant and left to settle in the geo-textile bags, with clean water seeping through the bags leaving the sludge contained inside.

SENZ notified the Council late last year of an exceedance of the consent compliance turbidity limit at the Ngakawau River monitoring site relating to the limestone dosing of the Mangatini Stream. This reflects the increase in complaints Council received during the latter part of 2009. Since then, SENZ notified the Council in early January 2010 that the turbidity levels had dropped to within the compliance limits imposed by Resource Consent RC06206.

This issue is likely to be resolved when the limestone dosing is moved upstream of the Mangatini Sump, which is scheduled to occur in March 2010. The Council has requested ecological monitoring results from SENZ in order to determine what, if any, adverse effects were caused by the increase in turbidity. A decision will be made on the most appropriate course of action once this information has been received.

Reefton Sites

A site visit was made to the Reefton coal load-out facility and Burkes Creek coal processing plant. The purpose of the visit was primarily to familiarise Council staff with the operations, and also to ensure there were sufficient mitigation measures in place to limit any contamination of surrounding waterways, particularly the Waitahu and Inangahua Rivers.

Disputes Tribunal Claim – J Cornish-Wright: The Council received notice of a claim lodged with the Disputes Tribunal by J Cornish-Wright relating to the charges that the Council invoiced to her for the monitoring of her whitebait stand consent in the Paringa River. The Consents & Compliance Manager will be defending the claim on behalf of the Council and has provided a statement of evidence to the Disputes Tribunal and Ms Cornish-Wright regarding the claim.

Mallinson reported that there were negative budget variances in the general rate funded areas of just over \$30,000, one of the contributing factors to this is the costs of the wetlands variation appeals which are now starting to impact. Not all stands have been inspected but all rivers or stands where there have been issues have been inspected. Cr Scarlett asked that for consistency purposes achieved or not achieved be put into the report, he sees this target as not being achieved.

Mallinson advised that two performance measures have been identified in the Annual Report that require attention from the management team. R. Mallinson advised that Councillors had previously confirmed that they are happy with the approach to Risk Management, however in this instance R. Mallinson stated he is recommending that we do not adopt the Audit New Zealand recommendation.

5.1.3 CABINET DECISIONS REGARDING TRANSPARENCY, ACCOUNTABILITY, AND FINANCIAL MANAGEMENT (TAFM) OF LOCAL GOVERNMENT

R. Mallinson spoke to this report and asked that it be taken as read. He advised he recently attended a meeting in Christchurch regarding the TAFM decisions. He stated that the sector did well with the lobbying against the proposal for referenda which would have cost this Council \$60,000 every three years.

Cr Birchfield asked if the costs of prosecutions are being itemised somewhere. R. Mallinson reported that the total costs of accrued prosecution costs is \$70,000. R. Mallinson advised that he has a breakdown of prosecution costs relating to specific prosecutions which he will present to the in committee section of today's meeting.

C. Ingle advised that from the information he has received from SOLGM and the Regional Affairs Committee meeting it is felt that this TAFM change is both positive and negative. There are

some issues that have been simplified and some new things that need to be done and it is thought that the administrative burden for councils will be about the same that it is now.

Moved (Davidson / Chinn) that this report be received.

6.0 CHIEF EXECUTIVES REPORT

C. Ingle spoke to his report. He advised that he and S. Moran met with most of the Grey District Councillors on the 13th of November to explain the design for the floodwall. C. Ingle stated that the Grey District Council is the owner of the floodwall and in accordance with our agreement with Grey District Council they manage the aesthetics, the amenity and the access to the floodwall. West Coast Regional Council's function in relation to the floodwall is to keep the floodwaters out of the town. C. Ingle stated this was a very good informal meeting and Grey District Council had some very useful input into how the floodwall could be made to look nicer and be an asset to the town. C. Ingle advised that the floodwall upgrade is scheduled to commence in January / February and should be completed by May. He stated that there will be some disruptions around Mawhera Quay and other floodwall areas during this time but there are other areas where the floodwall is not being raised and there won't be any disturbance in those areas. C. Ingle advised that S. Moran has arranged for a media article to be placed in The Greymouth Evening Star advising the public of what is happening with the floodwall so that there are no surprises once construction starts.

C. Ingle reported that he attended a meeting with the Ministry of Tourism to progress the cycleway proposal for the West Coast. He has also met with the Ministry of Social Development regarding this matter. C. Ingle stated that the cycleway is a big opportunity for the tourism sector of the West Coast if we can have a cycleway granted. C. Ingle advised he is assisting the district councils with their proposals for the cycleway. Grey District and Westland District Councils are joining forces to form a single cycleway rather than two separate ones. He advised there is a separate proposal for the Buller area which goes from the Lyell to Mokihinui, some of these roadways were formed by miners in the early days. C. Ingle stated he feels positive about the Cycleways because of the natural beauty of our area and the variety of landscapes that people will see off the main roads.

C. Ingle stated that the Wetlands court case is taking up a lot of his time.

C. Ingle drew attention to both Council's and VCS's submissions for the Proposed Tb Strategy for the West Coast. He thanked Cr Robb for his input to this and stated that it is important that the West Coast is treated fairly and not left out in terms of the new strategy.

Moved (Davidson / Chinn) that this report be received.

7.0 CHAIRMANS REPORT (VERBAL)

The Chairman reported that he attended the Regional Land Transport Committee meeting on the 17th of November. Cr Scarlett attended the Regional Affairs Committee, he stated that it was decided that a much more collaborative approach should be taken among regional councils. It was felt that there is a lot of information that regional councils have, in particular for water management and other environmental matters and it was agreed that this information would be pooled for the benefit of not only regional councils but also the rest of New Zealand.

Cr Scarlett spoke of the discussion at the Regional Affairs Committee meeting regarding the role and responsibilities of Local Government in treaty settlements, development and implementation. Cr Scarlett stated that this is borne out of the Tainui settlement from the Waikato, which has the potential to spread right throughout New Zealand, and it was felt that this matter needs to be discussed in committee today.

Cr Scarlett advised that the new proposed AHB Pest Strategy was discussed at the Regional Affairs Committee meeting. He advised the four mains points to come out of the meeting were; that local funding is to be spent within each region, the RAC Biosecurity subcommittee and the AHB representatives are to meet on an annual basis to review progress and effectiveness. AHB are to advise funding requirements for the three year long LTCCP period prior to public consultation to ensure council support for the Tb programme. Financial reporting arrangements

will be agreed to meet individual council requirements for example this could agreement to pay the regional funding share monthly, quarterly or biannual progress payments.

Cr Scarlett reported that the Regional Affairs Committee meeting also discussed the matter of regional councils needing to identify more to the general public as a lot of people don't understand what regional councils do. Cr Scarlett feels that the confusion arises because they are not always called regional councils. He gave the example of Horizons and Ecan's names and stated that some kind of branding that relates to the environment and the pooling of information that regional councils hold for the benefit of all of New Zealand would he helpful.

Cr Scarlett stated that he has met with the Chief Executive on various occasions during the reporting period.

Background

Inchbonnie and Taramakau Rating Districts

I attach the minutes from the 2009 round of Rating District Annual Meetings for the Inchbonnie and Taramakau Rating Districts. The minutes of the 2008 meetings for these two rating districts were inadvertently put to the December meeting.

The minutes contain recommendations from the Rating Districts with regard to the level of rating they endorse for 2009/10.

These recommendations will be included in our 2009/10 LTCCP and will be formally set as part of that LTCCP process.

Wanganui Rating District

The rating district put forward the following recommendation "That the \$30,000 S. Moran is holding goes toward the paying off of the road". It was explained to the rating district that this money is required for the restoration of the quarry because there is as yet no agreement to develop the quarry further.

My recommendation is that a formal resolution be taken by Council not to adopt the recommendation from the rating district.

P. Ewen opened the meeting and welcomed those present. He introduced himself and the Council staff.

FINANCIAL MINUTES

W. Moen presented the financial statements for the financial period ending 30 June 2009. He advised the account has a current credit balance of approximately \$61,793.26. W. Moen offered to answer questions.

Moved: "That the financial report for the 2008 / 2009 year be adopted".

D. Shaffrey / J. Keeney - Carried

MATTERS ARISING

There were no matters arising.

WORKS REPORT

W. Moen presented the detailed works report, which covered the 12-month period; 1 July 2008 to 30 June 2009. W. Moen advised that a large amount of expense related to the survey work carried out (\$30,085.00).

W. Moen carried out an inspection with W. Gault and D. Shaffrey on the 10th of August and as a result of this inspection \$54,090.00 worth of projected works were identified. D. Shaffrey noted that \$10,000 has been allowed for aerial spraying this year and last year it was only \$5,000.

- W. Moen responded that this is only an estimate and he expects it to be less than \$10,000 as it is to be done by helicopter. This job will be worked in with aerial spraying in the Taramakau Rating District so that a better price can be obtained.
- W. Moen advised that \$100,000 from Grey District Council is to go towards the upgrade of the stopbank. S. Moran confirmed that grass seed has been sown on the stopbank.

RECOMMENDATION

- 1. That the Works Report covering the 2008 / 2009 financial year be adopted.
- 2. That the 2009 / 2010 works proposals be approved.

J. Keeney / D. Shaffrey — Carried

RATES 2010 / 2011

W. Moen provided a rough outline of the costs to date for the stopbank. He stated that the original cost was approximately \$400,000 less the \$100,000 that Grey District Council contribution. MBD's quote was for \$147,000 and with fill required and widening of the road the whole job has come to \$181,478.00. Surveying from Chris Coll was costed at \$34,000, this included surveying on J. Keeney's property which was required by Electronet for the realignment of a power pole, this cost \$8,000. Culverts and floodgates came to \$43,500 and W. Moen's time to supervise the contract and to let the contract out came to just over \$3,000, vehicle charges were just over \$1000 and resource consent application was \$473. The total is approximately \$272,000.00. W. Moen stated this is a lot less than the \$400,000 that was estimated at the start of the stopbank upgrade. Cr Ewen stated that a good job has been done. Cr Ewen confirmed that 11 contractors tendered for the contract. D. Shaffrey asked what is the interest rate on the loan. S. Moran advised that he thought it might be about 6%.

Discussion ensued regarding the rate strike. W. Moen advised that with proposed works and the previous rate strike of \$40,000 the likely balance at the beginning of the financial year would be approximately \$78,000.00. He recommended a rate strike for the 2010 /2011 of \$40,000.

- D. Shaffrey stated that in view of the loan and survey work planned he would like the rates kept lower. W. Moen warned of not having enough funds in the kitty in the event of major works being required. J. Keeney stated that he feels this could be got away with for one year. Discussion took place on the likelihood of a major flood event and the risk of not having enough funds in the kitty.
- D. Shaffrey asked if Grey District Council would be likely to contribute in the event of emergency works being carried out. S. Moran advised that although it is not open ended they possibly would.
- D. Shaffrey stated that there is also \$20,000 allowed for unforeseen maintenance. S. Moran advised that the top is going to be taken off the quarry and this rock is available for use. He advised that in view of the contractor situation this might be a good opportunity to rip rap part of the stopbank.
- S. Moran explained the purpose of the LAPP fund to the meeting, he advised that it is unlikely the Government would pay out their 60% in this area as the usual practice is that they only to pay out if the town is affected in the event of a major catastrophe.

Moved: "That the recommended rate strike for the 2010 / 2011 financial year is \$ 20,000 GST Excl."

D. Shaffrey / J. Keeney - Carried

ELECTION OF OFFICERS

Moved:

"That W. Gault be re-elected as the spokesperson for the Inchbonnie Rating District for the 2009/ 2010 financial year and the committee consists of all members present."

GENERAL BUSINESS

W. Moen reported that the cross sections were done this year. These were previously done in August 2006 and it is recommended that they be done every three years. W. Moen advised that the results have revealed that there is a general build up in the area from the Stanley Gooseman bridge downstream to roughly opposite the quarry, there is build up all the way down and there is a depletion in the last section towards the gap. Overall there is a buildup of approximately 93,000 cubic metres of gravel. J. Keeney asked how much gravel was used for the new stopbank; W. Moen confirmed 48,000 cubic metres were used.

S. Moran commented that all parties were very cooperative through the resource consent process for the upgrade of the stopbank and a good job has been achieved.

Cr Ewen spoke of a recent seminar he attended. GNS Scientists were present, they used the alpine fault example with the Inchbonnie area being one of the scenarios. Core samples were obtained from trees in Lake Poerua, which revealed that as recently as 400 – 500 years ago the Taramakau River entered Lake Brunner.

There being no further business, the meeting closed at 10.55 a.m.

MATTERS ARISING

S. Langridge asked what is happening with NIWA and the flood gauge in place at the William Stewart Bridge. S. Moran advised that the information is downloaded quarterly and is available roughly every five months. S. Moran advised that WCRC is able to relate the levels back to a particular event if a flood is marked out on the gauge at the time and if the date of the event is known. M. Stewart stated that this is useful information. S. Langridge asked if a mark on the piles at a particular time then NIWA should be able to tell how much water is coming through that section at the time. W. Moen suggested that if cross sections are done then the velocity of the water going through could be gauged. S. Moran advised that there is a possibility of putting a staff gauge on but all it would do would give an indication as to how high the river is, more accurate information would be available once NIWA have downloaded the data and processed it. Someone would need to note dates when the river has been high to enable accurate results. S. Langridge asked if the recent floods have been analysed, S. Moran responded that results revealed that both were no more than 20 year flood events. S. Moran advised that the biggest cost involved would be putting the gauge onto the bridge.

W. Moen reported that the price for the survey of the stopbank requested at last year's meeting was \$6,5000 + GST. M. Stewart suggested putting this on the back burner for this year in view of money being tight.

W. Moen asked S. Langridge if there has been any development with the quarry. S. Langridge responded that there is plenty of rock around and is mindful that if the quarry is opened up then royalties would need to be increased to cover costs. S. Langridge stated that not all rock needs to come from a quarry, as there is plenty in paddocks.

W. Moen suggested to the meeting that they might want to consider stockpiling rock in case of emergency works. S. Langridge stated that there is already 500 - 600 tonnes dug out. S.

Moran stated that it is more convenient if the rating district buys the rock that way if rock is required for emergency work then it is already bought and paid for by the rating district. S. Langridge confirmed he is happy to stockpile the rock. Discussion ensued as to how much how is stockpiled, it is estimated that there is approximately 2000 tonnes stockpiled for emergency. It was agreed that W. Moen would ascertain how much rock is stockpiled and get back to S. Langridge with the figures and the exact location of the rock. S. Moran suggested that the rating district engage a contractor to stockpile the rock on their behalf. S. Langridge stated that careful consideration would need to be given to the price paid to contractors for stockpiling rock. W. Moen stated that \$2.50 per tonne would be a rough figure to recover rock out of the ground and to stockpile the rock. It was agreed that W. Moen would get prices from contractors for the stockpiling of rock with a view to having 2000 tonne of rock stockpiled behind the hook.

FINANCIAL MINUTES

S. Moran drew attention to the annual quarry fee. He reminded the meeting that the fee from 2007 / 08 was left out of last year's report and that is why there are two fees in this year's report. W. Moen advised that the closing balance is approximately \$4,757.14.

Moved: "That the financial report for the 2008 / 2009 year be adopted".

S. Langridge / M. Stewart - Carried

MATTERS ARISING

There were no matters arising from the financial minutes.

WORKS REPORT

W. Moen presented the detailed works report, which covered the 12-month period from 1 July 2008 to 30 June 2009. W. Moen advised that he carried out an inspection on 10 August 2009. Projected works for aerial spraying are \$10,000 and \$20,000 has been allowed for unforeseen maintenance. M. Stewart asked W. Moen if a price has been obtained for the aerial spraying. W. Moen advised that a price is not yet to hand but he is hoping to combine this job with Inchbonnie rating district's aerial spraying. Discussion took place on what area is sprayed and who pays for it. It was agreed that M. Stewart would work out the areas to be sprayed and pass this information onto W. Moen. W. Moen will then work out the payment for each individual. M. Stewart stated that he feels there may be the need to put one or two spurs out from Dymac Farms Limited area and also some work at the Hook Groyne. W. Moen stated that he would inspect this area in about a week or so to confirm if this work needs to be carried out. S. Moran advised it would be prudent to add this work to the proposed works report for 2009 / 2010. He advised with the proposed works in the Dymac area then the account could already be in deficit. Discussion took place on the cost of this work.

RECOMMENDATION

- 1. That the Works Report covering the 2008 / 2009 financial year be adopted.
- 2. That the 2009 / 2010 works proposals be approved.
- 3. That the proposed work at Dymac Farms Limited be included in the 2009 / 2010 works proposals.

RATES 2010 / 2011

W. Moen stated that with the rates coming in for this year and the works for the coming year this would leave approximately \$36,000 (GST Excl) in the account.

D. Groot asked what is the urgency for the groyne work in the Dymac Farms area. S. Langridge stated that the work that Nelson Cook has carried out on his property has altered the meander pattern of the river and this needs to be sorted out as the river is now cutting in on his property. S. Langridge is concerned that this work further up the river is now affecting this rating district and his property. It was agreed that D. Groot would send a letter to WCRC expressing the rating districts concern with the works carried out further up the river.

Discussion took place regarding the cost of the proposed works would have on the rate strike. W. Moen advised that in view of these extra works then the rate strike for the coming year needs to be carefully considered. S. Langridge stated that he feels that the rate strike can stay at \$60,000 as long as everyone is clear that if there is an event then they need to pay up for this. W. Moen stated that in view of the extra work then the account could go into overdraft fairly quickly. M. Stewart stated that this work needs to be timed so that it is completed before next spring's floods.

RECOMMENDATION

"That the rate strike for the 2010 / 2011 financial Year is \$60,000 (GST Excl)."

S. Langridge / M. Stewart - Carried

W. Moen stated that had he have been aware of the extra work required in the Dymac Farm area at the time of writing this report, his recommendation would not have been \$60,000 but close to \$100,000. Cr Ewen stated that Council would not be keen on any rating district having a negative balance and advised that if this happens then an extra meeting for this rating district would be called.

M. Stewart wondered if it would be worthwhile talking to landowners from Inchbonnie to ascertain what is now happening with the river. W. Moen stated the changes in the river might relate to illegal works carried out by new landowners further up the river as these works may have been carried out without a resource consent. S. Moran explained the usual procedure when someone applies for a resource consent and the impact of not applying for consent can have on others. S. Moran advised the meeting that should they see illegal works in their area they need to contact Council as soon as possible in order to avoid damage. W. Moen stated that sometimes an aerial inspection is warranted but this is costly.

It was agreed that all positions would roll over for this year.

W. Moen advised that the cross section work that was carried out in June of this year revealed that there is an overall depletion of 132,00 cubic metres between the top and bottom cross section. There is general erosion at the bottom end of the stopbank and a build up under the access road on the main stopbank and a general build up to the Old Christchurch Road up to the end of the sand.

M. Stewart asked if there have been any prospective buyers visiting council to discuss the rating district; in view of the fact that Dymac Farms Limited is for sale. S. Moran confirmed that a Real Estate Agent had visited him and he provided a copy of the contract to be signed by ratepayers relating to emergency work. S. Moran also emailed the real estate agent information relating to rating districts.

There being no further rating district business to be discussed, the meeting closed at 3.00 pm

3. General Comment

Total operating expenditure for the six month period to 31 December was \$3.756 million. Total operating revenues for the same period amounted to \$4.877 million.

The operating surplus for the period amounted to \$1.121 million

The Investment portfolio has shown a return of \$842,000 or 8.12% for the six months to 31 December 2009. This is very encouraging however I expect this to ease back somewhat given the dip in international markets in the latter part of January 2010. The budgeted return for the whole year was \$750,000 or 7.50%.

The Greymouth Floodwall upgrade is now underway. As Council does not own the Floodwall, the upgrade expenditure will appear as "above the line" operating expenditure, rather than capital expenditure.

I estimate that the loan drawdown required from Westpac for the Greymouth Floodwall upgrade project will be in the region of \$2.65 million. Funds arranged to borrow amounted to \$3 million, so there is scope to meet the borrowing requirements of other rating districts such as Inchbonnie and Lower Waiho, which was also envisaged in the LTCCP.

\$800,000 is programmed to be withdrawn from the Investment portfolio on 19 February 2010 representing existing Greymouth Floodwall credit balances. This is in accordance with the LTCCP.

In the general rate funded area, there were net positive budget variances amounting to \$32,605 for the six month period, despite cost pressures resulting from the Wetlands Variation Environment Court hearing and accumulated prosecution costs.

4. Annual Presentation by our Fund Managers Forsyth Barr Ltd

The team from Forsyth Barr Ltd will make their annual presentation to Councillors following the conclusion of the 9 March Council meeting.

Wetland Mediation and Progress towards Resolution

The Heads of Agreement was signed initially by Federated Farmers, Department of Conservation and Solid Energy, and was then signed by myself on behalf of the Council, and finally the other two parties also signed it after a day of mediation and a few minor changes. The Council and the Department are now working on consequential changes to the Plan, and organising a field worker to visit the proposed Schedule 2 wetland areas. The main focus of the fieldwork will be assessing the need for a buffer margin to ensure scheduled wetlands are not inadvertently affected by drainage activities on adjacent land.
